Measures to support accessibility

Young Vic Theatre takes the following measures to ensure accessibility of Home 20:

- Include accessibility as part of our mission statement.
- Include accessibility throughout our internal policies.
- Integrate accessibility into our procurement practices.
- Appoint an accessibility officer and/or ombudsperson.
- Provide continual accessibility training for our staff.
- Assign clear accessibility goals and responsibilities.
- We have accessed government guidelines and resources to ensure we are as compliant as possible.

Conformance status

The Web Content Accessibility Guidelines (WCAG) defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA. Home is partially conformant with WCAG 2.1 level AA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard.

Additional accessibility considerations

Due to the nature of the Content Management System we used to build this site, there are elements of the content that are compliant. In order to address this issue, we have created a video experience of this site, which can be viewed by people who experience accessibility barriers.

Limitations and alternatives

Despite our best efforts to ensure accessibility of Home 20, there may be some limitations. Below is a description of known limitations, and potential solutions. Please contact us if you observe an issue not listed below.

Known limitations for Home 20:

Alt text on images: Some of the images do not have alt text because The CMS we are using does not allow for this function. We have created a captioned video with voiceover that explores the site.

Moving images: Some of the images are flashing images because Part of the experience of the site. We have created a captioned video with voiceover that explores the site.

Sound effect video is not captioned: One of the videos is not captioned, as there is no clear speech and is a visual aid because the artists included this as



part of their process. We have created a captioned video with voiceover that explores the site.

Not mobile compatible: Website is not mobile optimised because the experience was designed for a desktop and the limitation of the CMS make it difficult to experience it on a mobile. We have created a captioned video with voiceover that explores the site.
