The Direct Debit Guarantee


- This guarantee is offered by all banks and building societies that accept instructions to pay direct debits.
- If there are any changes to the amount, date or frequency of your direct debit The Young Vic Company will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request The Young Vic Company to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your direct debit by The Young Vic Company or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- If you receive a refund you are not entitled to, you must pay it back when The Young Vic Company asks you to.
- You can cancel a direct debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

Data Protection at the Young Vic

We are committed to making sure you understand the control you have over the information you provide to the Young Vic. To complete your membership we will add the information you share with us to our database. This enables us to manage your membership including contacting you and administering your benefits. You can update your communication preferences online or by giving us a call at any time. We may also need to share your payment information with third party providers so we can process your payment or direct debit. For direct debits this includes a verification check with our third party processor Bottomline to ensure you own your bank account. Please note this check does access data available from credit reference agencies. We also use a third party to process direct debits on our behalf, called Rapidata.
